Incident Report

To: Brian Luce, Operations Manager Sunset Gower Studios

Incident Type: Terminated Employee, Suspicious Activity

Date of Report: June 5, 2018

I was contacted by Geoff Chow regarding an employee with their company (The Ringer) that had recently been terminated from their company. The employee was identified as Joe Fuentes. Since his termination he has been attempting to contact numerous employees within the company. Mr. Chow was concerned that Mr. Fuentes may try to return to the studios. It should be noted that upon his termination his credentials were taken from him. On his social media page he can be seen posing with a visitor drive-on pass. Although the reason for his termination was not discussed, it appears that Mr. Fuentes has been acting unusual and proclaiming himself to be God. All Security Officers have been briefed regarding the individual.

On Saturday June 2nd, 2018 Mr. Fuentes walked up to the security booth on Beachwood, he engaged Officer Jackson in conversation, he stated that he had entered a new line of work and was "making millions". Officer Jackson recognized him and had knowledge of his termination, he did not request access to the studios.

On Monday June 4th, 2018 @ 12:20 PM Mr. Fuentes returned to Beachwood gate driving a white Honda Civic, he stated that he had an appointment at United Recording and that he needed to park. Mr. Fuentes parked his car in the reserved parking stalls for United Recording and walked out of sight. Officer Nishanyan contacted Victor with United Recording and verified that Mr. Fuentes did not have business to conduct with them.

After Approximately 1.5 hours, Mr. Fuentes returned to his car, accompanied by another gentlemen. It appears that he had lied about going to United Recording and that he actually went across the street to have lunch. He was advised not to park in reserved parking or his car could be cited/towed. Mr. Fuentes stated that he thought East West Recording was part of United Recording Studios.

Note: Officer Nishanyan contacted East West Recording Studios to ascertain if Mr. Fuentes had business to conduct with them. They stated that he had called and reserved a studio. When he arrived and tried to pay for the studio his credit card was declined. He was asked to pay with cash, however when he returned he attempted to use the same credit card which was again declined. Mr. Fuentes left without taking his card.

I recommended to Mr. Chow that file a report with the Los Angeles Police Department, and obtain a restraining order if Mr. Fuentes make any threats to him or any of his staff.

Joe,

It came to our attention today that you tried to enter the Sunset Gower lot on Saturday and then again on Monday, and that you were denied entry on Monday by S/G security. We were alarmed to hear about this as you no longer have the right to access our property.

We're also alarmed that you have reached out in recent days to a number of our employees, by phone and by text, to denigrate The Ringer and in one case to say something that just wasn't appropriate to a female employee. We are also concerned about the confusing content on your Twitter feed and about feedback we've received from your recent trip back East.

We tried to check in today when Keav called, and we know that didn't go well, so now we are putting our concerns and future expectations in writing.

If you continue to approach Ringer employees without their consent, or if you try to get on the Sunset Gower lot again, we will have to involve law enforcement. If you want to have an honest conversation about whatever is going on with you right now, I'm happy to do so - we've known each other for 7 years and it's hard for me to fathom why you are behaving like this.
